# PGY1 Community-Based Pharmacy Residency

UVA Health offers an American Society of Health-System Pharmacists (ASHP)-Accredited PGY1 Community-Based Pharmacy Residency. During this 12-month program, residents are involved in high-quality patient-centered care, leadership and practice management, project management, and education of patients, health care providers, and trainees.

Pharmacist residency education and training in community-based practice aims to develop pharmacy leaders who are capable of improving the health of patients within the communities they serve. The purpose of the PGY1 Community-Based Pharmacy Residency is to build upon the doctor of pharmacy (PharmD) education and outcomes to develop community-based pharmacist practitioners with diverse patient care, leadership, and education skills who are eligible to pursue advanced training opportunities including postgraduate year two (PGY2) residencies and professional certifications.

### Residency Benefits

Current resident benefits include:

- Stipend of \$54,650
- Vacation/holidays (n=15)
- Sick (n=14) and interview (n=5) days
- Premium medical/dental/vision insurance
- Professional leave to attend meetings (ASHP Midyear and the regional residency conference)

### Application Requirements

Applicants must be:

- Enrolled in or a graduate of an ACPE-accredited PharmD program
- A licensed pharmacist in the Commonwealth of Virginia by September 1

**Completed application materials must be uploaded into PhORCAS by December 27**

## **Justin L. Vesser, PharmD, MS (he/him)**

## **Department of Pharmacy Services**

The UVA department of pharmacy has over 300 team members who practice in various areas ranging from administration and business services, clinical inpatient care, and ambulatory settings. The inpatient hospital pharmacy provides decentralized dispensing and clinical services to an average daily census of 528 patients. Sterile compounding for patients occurs in a newly renovated state-of-the-art IV clean room. The department operates numerous pharmacist-run outpatient clinics, several outpatient dispensing pharmacies, a specialty pharmacy, mail order, and home infusion services. The entire department has extensive technology and automation to provide innovative and safe care. Recent outpatient pharmacy, outpatient surgical services with associated pre and post-op clinical pharmacy care, and community hospital expansion has allowed UVA to provide pharmacy services to an increased number of patients throughout the state.

Ambulatory pharmacy services are comprised of six retail pharmacies and clinical ambulatory pharmacy services. The retail pharmacies provide advanced clinical services, including immunizations, medication therapy management, and targeted high-risk medication education. There is also a focused effort on improving transition of care including medications to bedside services and discharge education. The ambulatory pharmacists participate in an employee population health initiative with the goal of improving overall health.

# PGY1 Community-Based Pharmacy Residency Program Overview

## Application Requirements

Applicants must be:

- Enrolled in or a graduate of an ACPE-accredited advanced pharmacy program
- Eligible for licensure in Virginia and licensed by September 1

Applicants must upload the following to PhORCAS by the specified deadline:

- Curriculum vitae
  - Include completed and anticipated advanced pharmacy practice experience rotations
  - Include leadership and organizational involvement
- Letter of Intent
- Official college of pharmacy transcript
- Three references/letters of recommendation from preceptors able to reflect on fourth-year advanced pharmacy practice experiences (not in the classroom). References must comment on the following characteristics:
  - Ability to organize and manage time
  - Ability to work with peers and communicate
  - Clinical problem-solving skills
  - Independence and resourcefulness
  - Willingness to accept constructive criticism
  - Professionalism

An interview with the residency program director, pharmacy leadership, and preceptors is required.

Please note: UVA Health Residency Program does not sponsor work visas.

## Orientation

The 2022-2023 UVA Health System Residency will begin on July 1, 2022 and will end on June 30, 2023.

Mandatory housestaff orientation will begin in mid-June with the entering medical residents. As part of residency orientation, residents will rotate through various areas of the Department of Pharmacy Services and develop skills required for the provision of pharmacy services. Most rotations are five weeks in duration and begin following orientation. ## PGY1 Community Pharmacy Rotations

### Required Rotations

- Orientation
- Community Pharmacy I: Pharmacy Operations
- Community Pharmacy II: Transitions of Care
- Community Pharmacy III: Population Health
- Inpatient: Internal Medicine or Internal Family Medicine
- Ambulatory Care: Internal Medicine
- Administration

### Elective Rotations

Residents will have up to three rotations (15 weeks) available for elective rotations. Additional rotations may be developed based on resident interest and preceptor availability.

- Specialty Pharmacy
- Inpatient/Outpatient Cardiology
- Inpatient/Outpatient Solid Organ Transplant
- Ambulatory Care: Family Medicine Clinic

### Longitudinal Service

- Residents will staff in the UVA Outpatient Pharmacy 16 hours every third weekend and 4 hours one night per week (most weeks) for a total of 416 hours over 12 months. Residents will work one major holiday and one minor holiday.

## Research Activities

Completion of a major research project is a requirement of the residency. Final reports must be submitted in manuscript style and approved by the project advisor and program director.

During the first half of the year, each resident will also complete a quality improvement project. Completed projects will be submitted for poster presentation at the Vizient Pharmacy Council meeting held in conjunction with the ASHP Midyear Clinical Meeting.

## Presentation Requirements

Residents are required to present results of their quality improvement project at the Vizient Pharmacy Council Poster Session at the meeting held in conjunction with the ASHP Midyear Clinical Meeting. The results of their residency research project will be presented at the regional residency conference. Additionally, each resident is responsible for presenting one ACPE-accredited pharmacist seminar, one ACPE-accredited tech talk, as well as patient case presentations and journal clubs.

## Service Component

Residents provide service in the UVA Outpatient Pharmacy. Responsibilities include medication dispensing, patient education and counseling, immunizations, support of discharge services and supervision of pharmacy interns. Participation in the service component provides necessary training and allows the residents to meet the intent of the ASHP residency standard.

## Certification

The PGY1 Community-Based resident has the option to complete ACLS training and certification. This training is offered through UVA Medical Center at no charge to the resident.

## Teaching

Through a partnership with the Virginia Commonwealth University (VCU) School of Pharmacy, UVA Health pharmacy residents have the opportunity to earn a Teaching and Learning Certificate. As part of the VCU School of Pharmacy-UVA Division Satellite Campus, residents have the opportunity to interact with pharmacy students completing their third and fourth professional years at the UVA campus. Furthermore, the Department of Pharmacy Services serves as a rotation site for introductory and advanced pharmacy practice experiences for VCU and Shenandoah University School of Pharmacy students. Residents will have a variety of teaching opportunities that include didactic experiences and precepting students on rotations.
