How to Maintain EMT Certifications or Attain Reciprocity

National Registry and Virginia have an agreement that states if a provider has met Virginia recertification standards, they can be recertified for National Registry. The number of CE credits that can be earned online (distributive) and counted toward recertification is unlimited in Virginia. That means that National Registry will allow the identical process for distributive learning.

National Registry is a 2-year certification, whereas Virginia has 4-years (BLS) and 3-years ALS certifications. Therefore, it is important to manually recertify your Virginia certification after 2 years, in order to keep the CE report reflective of what is needed for NREMT.

Virginia Recertification Process

NCCR (Cat 1) – Only 5 General Areas: Airway, Cardiovascular, Trauma, Medical and Operations. Unlike NREMT, there are not specific breakdowns that are necessary in each area. Any NCCR CE that exceeds the required amount will roll into LCCR/ICCR. (Category 2/3).

LCCR/ICCR (Cat 2/3) – No specific areas are needed. Anything that does not fall into NCCR or is in excess of NCCR will apply to this category.

- 1. Once all CE hours for Virginia are complete, go into your VAOEMS Portal and print off a copy of your CE Report and retain for records.
- 2. Log into your NREMT account and follow VAOEMS Quick Guide to enter in CE. DO NOT ENTER individual hours.
- 3. Once you have recertified NREMT, go into VAOEMS Portal at the end of the NREMT certifying month and go into My Tests/Eligibility → Eligibility Letter → check box "Recertify Me". This will reset your CE with VAOEMS and generate a new VA certification card.
